

### Version 2.42 Release Date: November 14, 2023

The CYRISMA 2.42 release includes bug fixes, minor UX enhancements, and feature updates including the brand new Industry Comparison feature. Industry comparison enables users to compare their cyber risk posture with that of other organizations within the same industry. They can also see specific comparison stats under each of CYRISMA's core assessment categories.

#### Admin

- **Integrations** - Added a button that verifies established credentials
- **Scan Agents** - Edit existing scan agent modal- in the last 5 tasks completed section: the seconds column of the timestamp is now capped at two places
- **Scan Agents** - HTML tags no longer appear in the 'Running Task' column of Agent Status
- **Scan Agents** - In the Provision New Agents modal, the 'Type' drop-down menu is now working
- **Targets** - On the 'update existing target' form, the 'Security Apps Discovered' field is no longer showing HTML tags
- **Targets** - Target Scan Summary modal- root cause table now has a pager which displays all results
- **Targets** - Target by OS- the 'IOS' button has been renamed to 'macOS'
- **Targets** - On the 'Add A New Target' form, the 'Submit Updates' button is now 'Submit'
- **Targets** - The Network Discovery Scan Results modal is no longer showing HTML tags
- **Targets** - The Network Discovery Scan Results modal now has a select all checkbox
- **Users** - When updating a user, entering a password is no longer required to submit changes. The 'show password' & 'generate password' actions have been added
- **Users** - When updating a user, the 'Email' field now only accepts email formats

#### Compliance

- **AD Monitor Results** - Users in Domain modal- The 'All Users' drop-down filter is now working correctly
- **AD Monitor Results** - Computers in Domain modal - The 'All Computers' drop-down filter is now working correctly
- **Industry Comparison** - Feature Implemented

# CYRISMA Version 2.42 Release Notes (Contd.)

## Dark Web

- Added a 'Status' column to Dark Web Monitors that shows if a Domain is pending validation or validated
- Upon validating a domain, the user is now shown a success message and is no longer redirected to the login page
- While editing a monitor, the 'Domain Name' field is now read only
- Fixed an issue where submitting multiple IP addresses would cause an error

## Dashboard

- **Compliance Tracker** - Now has a button linking to 'Industry Comparison'
- **Compliance Tracker Modals** - Now displaying all applicable standards
- In the **Financial Impacts modal**, currency values are now capped at two places past the decimal
- The **Target Risk Matrix modal** now displays 'scanned' targets by default
- **Residual Risk Cost modal** - The option to switch the slider from 'Y' to 'N' in the 'Reduce your residual risk cost by addressing these factors' section is disabled. To transition the slider to 'N', users are required to click the trashcan icon

## Data Scan

- **Scan History** - Mitigation plan names are no longer showing Scan IDs
- **Scan History** - In the 'Top 5 locations with' section, the drop-down menu selection 'Most Sensitive Files' is now spelled correctly

## Mitigation

- **Create a Mitigation** - In the various scan history sections- after clicking the '...' button to create a mitigation plan, the scan name now correctly populates in the 'select scan name' drop-down
- **My Mitigation Plans** - Drop-down filters are now working correctly
- **My Mitigation Plans** - Vulnerability Scan plan modal- Table sections that show vulnerability severities with number/letter ratings and colors no longer appear to be clickable
- **My Mitigation Plans** - In the Mitigation Summary modal, corrected some grammar issues
- **My Mitigation Plans** - Added filter to sort by scan type

## Report Builder

- The functionality for emailing a Secure Baseline report is now operating correctly

## Secure Baseline

- **Schedule a scan** - Group scans now have offline delay functionality

## Sidebar Menu

- When this menu is collapsed, hovering over an icon now displays its name.
- When this menu is collapsed, the Agent Status icon is now present

## Site-Wide

- Cleaned up pop-up messaging after clicking submit on the following pages: Admin-Users, Admin-Departments, and Admin-System
- Donut charts percentages are now displayed in the chart legends in the various scan histories, scans in progress pages, and mitigation review pages
- **Schedule a Scan pages** - Scan names must now be unique
- Reference links within modals now display the URL address they are linking to upon mouse-over

## Vulnerability Scan

- **Scan History** - Reference Links found in the host vulnerability summaries of Internal Unauthenticated and External Scans now are formatted like the Reference Links found in Internal Authenticated scans
- **Schedule a Scan** - In the 'Scheduled Vulnerability Scans' table, the 'Next Scan' column is now considering the year when sorting
